## Aura Reyes, Lindsay Ann Pacheco, Cathy Kawano-Ching, James Koshiba '91

Aura Reyes is a co-founder of Ka Po'e O Kaka'ako (KPOK), a houseless community that lived together in Kaka'ako Gateway Park, where she organized community, coordinated service projects and forged relationships between houseless individuals and service providers. Currently, Aura sits on the Board of Directors for Partners in Care, is a member of Hui Aloha and a Housing Affordability Fellow.

Lindsay Ann Pacheco is a co-founder and leader of KPOK. After many years on the street, Lindsay got housed in May 2020, re-enrolled herself in college, and is now pursuing a degree in Social Work while continuing to conduct outreach and advocacy for those who remain houseless.

Cathy Kawano-Ching is a founding member of Hui Aloha, an educator, and life-long learner. Her connections to houseless communities began 11 years ago when working with youth living in homeless shelters and on the streets in Kaka'ako.

James Koshiba is co-founder of Hui Aloha. Formerly, he was Executive Director of Kanu Hawaii, building grassroots movements for sustainability. Born and raised on Oahu, he earned degrees from Brown University and the Harvard Kennedy School of Government.

## Mark Noguchi '93

Food and Sustainability Curriculum Specialist, Punahou School

Mark was born and raised in Mānoa Valley, Oʻahu. As a chef, Mark navigates Hawai'i through the lens of food, always with the intent to gather, connect and harmonize the communities he serves. At He'eia Kea Pier General Store & Deli, his insistence on sourcing hyper-local ingredients garnered national acclaim. Through Taste Table, he helped revitalize the Kaka'ako food scene by providing a space for up-and-coming local chefs, many of whom are now nationally-renowned for their work. MISSION Social Hall & Cafe, Mark's most recent project, was published by Taste Talks as one of the six best museum cafes in North America.

In 2012, Mark and his wife Amanda Corby Noguchi started Pili Group, their life's work. Pili is dedicated to creating a better world through food, education and community.



### **Dr. Darragh O'Carroll '03** Emergency Physician

Darragh O'Carroll, M.D. is an emergency physician, writer, medical consultant and CNN contributor. Dr. O'Carroll received his emergency medicine residency and medical internship from the University of Southern California + Los Angeles County Medical Center, his medical doctorate from the University of Hawai'i John A. Burns School of Medicine and his Bachelor of Science in Human Physiology from Boston University.

He is a volunteer medical officer for the Polynesian Voyaging Society where he served on the return leg of the Ala Hula Kai O Maleka voyage from San Diego to Honolulu, and medical operations officer for the disaster response agency Team Rubicon, most recently providing disaster relief to the Bahamas in September of 2019 after category 5 Hurricane Dorian.



### Miki Tomita Founder and CEO, Education Incubator

Miki is the Founder and CEO of Education Incubator, a Hawai'i-based nonprofit dedicated to empowering young people, adults and communities to live with passion and purpose in service of a better world.

She has worked in education for 20 years as a teacher, administrator, curriculum developer, and researcher.

Born and raised on Maui, Miki graduated from H.P. Baldwin High School, earned a B.S.E. in Biosystems Engineering at the University of Hawai'i at Mānoa, and a Ph.D. in Education at Stanford University.



## Sarah Craven '81

Director, United Nations Population Fund, Washington Office

A policy advocate and attorney with experience in global health and human rights, Sarah currently serves as the Director of the Washington Office of the United Nations Population Fund (UNFPA). She has worked on advocacy campaigns focused on empowering women and girls. Prior to her work at UNFPA, she held positions at the U.S. Department of State and on the legislative staff to U.S. Senators Tim Wirth of Colorado and Spark Matsunaga of Hawaii.

She received degrees from Macalester College, Cambridge University (UK) and Georgetown University Law Center where she was a Public Interest Law Scholar.

In 2021, she was named one of Apolitical's 100 most influential people in gender equality.





### Senator Glenn Wakai Hawaii State Senator, District 15

Glenn Wakai is in his second term as a Hawaii State Senator, following eight years in the State House of Representatives. He is the current chair of the Senate's Committee on Economic Development, Tourism, and Technology, vice chair of the Committee on Public Safety, Intergovernmental, and Military Affairs, and is a member of the Committees on Human Services and Ways and Means.

In 1991, Glenn began a career in television news by working as a reporter/anchor in Guam and Saipan. He later returned home to work for KHON-FOX2 and KHNL NBC 8. After 11 years in news, Glenn set aside his microphone to pursue his passion for public service. In November 2002 he was elected to the Hawaii State House of Representatives and was re-elected in '04, '06, and '08. Outside of the legislature, he runs a non-profit organization, Reach out Pacific (REPAC), which takes surplus medical and educational equipment to Pacific Islands and sits on a number of boards within the community.



### **Dawn Lippert** Founder and CEO, Elemental Excelerator

Elemental Excelerator is a global climate technology investor and non-profit impact organization.

In 2020, Dawn received the UN Global Climate Action Award, recognizing her contribution for "Pioneering a New Funding Model for Climate Tech." She is a board member of Climate Real Impact Solutions II, a climate-focused special-purpose acquisition company.

Dawn was named a Grist 50 Fixer in 2019, served as a 2015 Omidyar Fellow, and was honored with the 2015 C3E Award from the U.S. Department of Energy and the Clean Energy Ministerial. She is passionate about inclusion in technology, and in 2010 founded the non-profit organization WiRE (Women in Renewable Energy).

Dawn graduated cum laude from Yale University with a B.A. in Environmental Studies, and received her Master's degree from the Yale School of Forestry and Environmental Management.



### **Celeste Connors '94** Executive Director. Hawai'i Green Growth

Ms. Connors has twenty years of experience working at the intersection of economic, environment, energy, and international development policy. Before joining Hawai'i Green Growth, she was CEO and co-founder of cdots development LLC, which works to build resilient infrastructure systems and services in vulnerable communities.

She previously served as the Director for Environment and Climate Change at the National Security Council and National Economic Council in the White House where she helped shape the Administration's climate and energy policies, including the Sustainable Development Goals (SDGs). She held positions at the U.S. Mission to the UN, served as the Climate and Energy Advisor to the Under Secretary for Democracy and Global Affairs at the U.S. Department of State, and worked for City of New York.

Ms. Connors grew up in Kailua.







### **Taylor Darling** Co-founder Santa Cruz Green Builders

Taylor grew up on the island of Kauai and loved constructing things from a young age, designing and building a tree fort that included a drawbridge, living room, kitchen, screened porch, and garage, and eventually helping his parents build their family home. While attending college, he studied sustainable building methods and made the connection that better buildings could solve some of the worlds problems with housing, pollution, and energy use.

After graduating, he founded a company, Santa Cruz Green Builders, with his brother-in-law. 14 years later, the company has grown into a design/build firm, that focuses on green building for residential and commercial projects.





# Mag. Judge Wes Reber Porter

United States District Court

Judge Wes Reber Porter began his career as a Trial Counsel for the Judge Advocate General (JAG) Corps in the United States Navy stationed at Pearl Harbor. He then worked as a Special Assistant U.S. Attorney for the District of Hawaii handling civil matters filed against the United States. Judge Porter next served as an Assistant U.S. Attorney for the District of Hawaii, a Senior Trial Attorney with the U.S. Department of Justice's Criminal Division, Fraud Section, in Washington D.C., and an enforcement attorney at the U.S. Securities and Exchange Commission in its San Francisco Regional Office.

Before his appointment, Judge Porter also served in academia as a tenured law professor and the Director of the Litigation Center at Golden Gate University School of Law in San Francisco, and as a visiting professor at the Richardson School of Law. He remains active in education and the community.





## Alex Yee '09

Mr. Yee joined the City and the Resilience Office in March 2021. #### United States Attorney for the District of Hawaii

Ms. Connors currently serves as the United States Attorney for the District of Hawaii. As the top-ranking federal law enforcement official in the State, she oversees an office responsible for prosecuting federal crimes related to national security, public corruption, drug trafficking, violent crime, child exploitation, complex fraud matters. Previously, she served as the 16th Attorney General of the State of Hawai'i where she was the chief legal and law enforcement officer of the State, responsible for providing advice and counsel to state executive and legislative branches, investigating and prosecuting state and federal crimes, and initiating civil enforcement actions.

Raised in Hawai'i, she graduated from Punahou School and Yale College ('96). She served for three years as the Operations Coordinator for the City of New York, Parks & Recreation Department before attending Harvard Law School. She began her legal career as a trial attorney prosecuting federal crimes, first with the U.S. Department of Justice's Tax Division in Washington, D.C., then in the U.S. Attorney's Office in the District of Hawaii.

Ms. Connors has been active in both the state and federal bar associations, and was the pro bono coordinator for the United States District Court for the District of Hawaii.
